

## Gender mo Protection Checklist | Shelter mo Reconstruction

### From wanem nao gender mo social inclusion, mo protection hemi important program lo saet blong shelter(haos) mo olgeta kakae?(NIFs)

- Lo taem blong disaster, pipol oli bin move aot lo olgeta haos mo faenem nara ples blong hide lo hem from haos blo olgeta hemi bin foldaon. Shelter hemi wan safety, respect lo life mo proteksen.(Hemi mean se igat prevention lo saet blo olgeta fasion nogud we pipol isave mekem from laef nomo. Olsem exploitation, abuse, violence mo givim kil no nara wan.
- Long taem blong buildem back shelter, imas gat care from ol nara problem. Olsem haos ino buildem gud mo shelter isave foldaon mo kivim mo kil long yumi.
- Evriwan igat raet long gat shelter so hemi important blongmekem sua se yumi gat tink abaot tu olgeta wetem special nid, se olgeta tu oli mas gat access lo materials mo NIFs. Pipol wetem special nid hemi includem olgeta woman, gel mo boe, pipol wetem disability mo olfala.
- Taem yumi understandem gud ol nid blong pipol wetem special nid mo targetem gud olgeta wetem shelter support, hemi helpem komuniti blo wok kwik taem mo buildem back olgeta lo saet blo disaster mo resilience.

### Assessment

- Toktok wetem olgeta pipol wetem special nid blo mekem sua se yu harem save' vois blo olgeta. .e.g mekem sua se ol woman, gel mo boy mo pipol wetem disability I toktok blong hem wan(suppose hemi save toktok).
- Checkem gud olgeta shelter blong pipol wetem special nids lo komuniti. Tekem record lo saet blong sex, age, disability mo prioritism olgeta(e.g olgeta woman, hao mas pikinin lo wan haoshold mo hao mas pikinini wetem disability).
- Checkem olgeta different NFI nids long pipol wetem special nids mo memba blong komunity, e.g sanitary material blong olgeta woman mo gel or nid blong olgeta wei inidem wheelchair mo oli no save wokabaot.
- Checkem namba blo olgeta pipol we oli mov igo aot long haos blong olgeta. Checkem namba blong shelter we olgeta igo stap long hem:
  - Wanem nid blong olgeta woman, man, gel mo boe from space, privacy mo fashion blong hygiene lo wan safe life mo respect.
  - Olgeta wetem disability hao mas nao imas wokabaot long wei blong kassem wan shelter?
  - Wanem nao komunity imekem blong supportem olgeta pikinini long home, iliv lo street, ino gat ples blong stap lo hem?
- Igat any risk/problem lo saet blong shelter, e.g.
  - Igat enough shelter or space long shelter, igat raorao or no?
  - Taem blong evacuation, olgeta pipol igat enough space or oli plenty tumas lo wan ples mekem se igat risk long ol woman, gel mo boe? Igat any fasion nogud iappem olsem sexual violence mo fasion blong treatem nogud olgeta woman?

## Access

---

- Prioritisem nid blong pipol wetem special nid blong shelter mo followem NFI distribution; e.g ol woman mo pikinini, pikinini we ihed lo wan haoshold, pikinini we istap hemi wan lo haos, ol disability mo olgeta olfala.
- No strick tumas lo taem blo registerem olgeta haoshold from olgeta shelter/NFI assistance; no gat nid blo separatem registration lo pikinini we hemi stap wetem samfala adults lo wan haoshold. Hemi no gat nid blo mekem dublication lo registration.
- Faenemaot lo komuniti namba lo olgeta pipol wetem nid mo hao mas nao oli nidem buildem bak shelter. Wetem NFIs, e.g. provision lo olgeta nids blo pipol wetem disability. Olsem olgeta ramp mo hand rail. Mekem sua igat enough pipol blong mekem olgeta check out wok lo shelter/building. Mekem sua se shelter hemi alright mo safe blong stap long hem.
- Mekem sua se olgeta place blong distribution, ol pipol, oli save kassem. Tinkabaot olgeta wetem diability tu. Olsem distribution place hemi no mas long we, tinkabout stret taem, tinkabaot se ol pipol bae oli stanap lo longfala line(queue) or separatem location. Mekem sua se pipol wetem special nid oli mas kassem support lo materials, or sendem support igo long olgeta.
- I mas gat gender balance long olgeta staff long taem blong distribution. Mekem sua blong includem samfala woman o gel olsem hed lo distribution point.
- Komuniti Infomasen lo shelter/NFI distribution hemi save go aot lo plente' fasion. Usem extension worker, radio, sms messaging, poster, newsletter, television or loudspeaker), blo mekem sua se evriwan ikassem infomasen.
- Usem principle blong "Build Back Better" taem constructem wan home or komuniti building blong helpem movement blong olgeta wetem disabiliti or olfala.
- Tink abaot olgeta fashion we olgeta long komuniti I save blokem rod blo accessem olgeta suppot blong shelter mo NFI distribution. Discussem wetem olgeta komuniti lida olgeta way blong stoppem fashion nogud olsem discrimination, exploitation mo abuse.

## Safety mo dignity

---

- Wetem pipol long special nid, faenem aot ol safe way blong lukaotem gud olgeta distribution lo shelter mo NFI mo building wok. Tinkabout, safe ples, road blong kassem building site, taem blong distribution, lo day taem, hao blong mekem distribution for safety blong olgeta pipol wetem special nid, security patrol mo ol narafala samting blong mekem distribution ifair, gud mo easy.
- Providem NFIs blong personal hygiene, proteksen mo distributem olgeta sanitary material lo olgeta woman mo ol gel lo sem ples.
- Monitorem mo providem support blong solvem olgeta risks lo exploitation, abuse, violence or fashion blong raurau.
- Ripot bak lo gender based violence specialist long olgeta case long wan safe mo confidential way. Explainem hao blong deal long olgeta case we yu faenem long komuniti, hemi lo saet blong exploitation mo abuse. Includem long ripot, nem blong Support Service we i providem help long case ia.

## Participation, empowerment mo accountability

---

- Providem guidance mo training blong olgeta staff blong save' olgeta situation mo olgeta capacity blo olgeta wetem special nid.
- Infomem olgeta beneficiaries lo saet blong raet blong gat access lo shelter mo wea ples nao oli save kassem material long hem. Usem olgeta komunikesen mo Infomasen Material.
- Meksua olgeta pipol wetem special nid oli mas tekem part lo decision-making lo saet blong shelter mo NFI programs blong isave support nid blong olgeta, e.g lo wea ples haos bae istap lo hem, plan mo blong building haos. Developem some system blong olgeta boe mo gel isave participate meanifully long olgeta wok blong construction.

- Providem job opportunity blong olgeta woman mo man lo construction mo maintenance long olgeta shelter.
- Providem training mo policies lo olgeta staff lo saet blong prevention lo sexual exploitation mo abuse. Infomasen igo lo komuniti hemi mas clear se olgeta woman mo ol gel ino nid blong payem or providem olgeta nara service blong winem wan shelter or NFI assistance.
- System support service we hemi accessible lo everi wan isave go lodgem complaint long wan confidential mo safe way.

## Monitoring

---

- Collectem mo monitorem olgeta data long olgeta we oli receivem assistance. Data hemi mas be by sex, age mo disability.
- Monitorem mo faemaot se hu ia ino gat access lo shelter mo NFIs, mo from wanem? Providem olgeta possible way blong support.
- Monitorem gud se olgeta pipol oli kassem support lo shelter mo NFIs, oli usem ol support ia or no?
- Lo evri support lo shelter mo NFIs, mekem sua se I gat wan leta we person we I receivem support ia mo stakeholder olsem (Area Secretary/Chief/donor) oli signem. Hem ia wan security blong nara person ino claimem se I blong hem.
- Monitorem gud se ino gat nara problem i kirap we might yumi no tinktink lo hem taem yumi providem support long shelter mo NFIs mekem se igat samfala disturbance. E.g lo selection support.
