

Key Messages – Ambae Volcano Resettlement on Maewo and Santo 17:00 21 September 2018

State of Emergency is extended to 26 November 2018

- COM Decision 149/2018 has directed for the extension of the current State of Emergency (SoE) for a further two months – to 26 November 2018.
- Any resettlement back to Ambae is prohibited until the SoE lapses.
- During the State of Emergency, NDMO has the power to restrict movement and prosecute obstruction to operations.
- During the period of the SoE, food supplies and essential services will continue to be provided to displaced Ambaen communities in both Maewo and Santo.

Manaro Vui Volcano is at Level 2

- Ambae volcano is in the major unrest state. The current volcanic activity is consistent with Volcanic Alert Level 2. Possible imminent eruption could occur at any time in such major unrest state.
- The presence of ash that has fallen on Ambae during the last eruption will continue to change the behaviour of streams and creeks when it rains. The creeks and streams can produce floods and carry a lot more debris (sands, gravel and boulders). The flow path of streams and creeks could change due to the flood debris. Landslide may occur at some areas during heavy rain fall.
- These observations and the analysis of seismic data confirm that the volcano activity is in the major unrest state. The volcano activity consists of ongoing emission of steam and/or volcanic gases.
- Significant impact of ashes and gases emission to villages at Ambae started in March and July, when the Volcanic Alert level was raised to Level 3. Level 2 indicates 'Major unrest; Danger is now at 2 km around the volcanic vents and areas inside the Yellow Zone.' The possibility that the Ambae volcano activity escalates to the level of minor eruption is now low but continually fluctuates.
- Villages in some areas may continue to expect change in streams and creeks flows during rain fall. Villages from Ambae island may experience impacts of volcanic gases especially those exposed to prevailing trade winds direction.

Maewo is 'second home' for Ambae volcano evacuees

• Maewo is the approved 'second home' for evacuees of the Ambae volcano

- Access to land on Maewo for Ambae evacuees is to be facilitated through the Chiefs of both Maewo and Ambae through the 'customary adoption and integration mechanism' as approved in the COM Decision 149/2018.
- State Law Office is currently drafting an agreement to secure access to land via customary arrangements for Ambae evacuees.
- Maewo and Ambae chiefs are currently meeting to discuss and agree on detailed terms of adoption land use.
- Agencies have been working to support communities. They have also put forward longer term plans across all sectors to support resettlement (food security, shelter, water and sanitation, education, Gender & Protection etc), however final plans can only be confirmed once access to land is determined.
- GoV service upgrade in Maewo will continue into the long-term, including provision of healthcare and education and other essential services. GoV planning also includes sustainable projects to support livelihoods, safe shelter options and associated training.
- The Shelter Cluster is planning upgrade to emergency shelter in evacuation centers in preparation of cyclone season.
- Water safety and security must be protected. Any obstruction or damage to catchment is prohibited.
- A mechanism for feedback from communities is being developed.

GoV will continue to provide food supplies to evacuees on Santo during the term of the SoE

- Food supplies will continue to be provided to Ambaen evacuees on Santo during the period of the SoE.
- Direct assistance on Santo after the SoE is yet to be determined by GoV, however normal services will be ongoing.
- There is no government decision regarding support to Ambae following the State of Emergency.
