

## Gender mo Protection Checklist | Disaster Response

### From wanem nao gender mo social inclusion, protection hemi important long disaster response?

- Natural disaster I affectem pipol long ol different way. Disaster I save affectem social structure, kastom mo ol role blong komuniti oli save affectem pipol lo different way mo problem blong samfala isave nogud bitem narafala. Pipol olsem ol women, gel, boy, olgeta we oli handicap mo ol olfala pipol oli save affected big wan.
- Disaster response hemi save givem safety mo respect ikam bak long wan komuniti(protectem mo response lo exploitation, abuse, violence mo injury).
- Pipol I gat different ol nid mo capacity blong facem ol different risks during mo after wan disaster. Evriwan I gat raet blong providem support long taem blong disaster mo hemi important se olgeta support ia hemi mas includem olgeta pipol wetem special nid. Disaster response hemi mas mekem assessemment long olgeta nid ia mo addressem everiwan semak.
- Taem disaster response hemi involvem ol woman, pikinini, ol youth mo pipol wetem disability lo program blong recovery mo resilience building, wok blong wan komuniti isave finis quick taem.

### Fesfala Warning mo Evacuation

**Step 1 |** Makem sua se ol woman, gel, boe mo pipol wetem disability oli aware long early warning mo evacuation process.

- Mekem sua infomasen hemi mas reachem everi pipol. Kivim aot early warning lo different form blong media(Olsem phone, sms messaging, radio, television, loudspeaker, nuisleta, mo throughout long komuniti network). Mekem sua information hemi mas kassem everiwan(olgeta we oli no rid gud, deaf, blind mo ol pikinini tu) e.g checkem gud se inogat rough wok long olgeta woman, olsem laef blong wan woman hemi save stap long wan risk finis mo husband hemi save usem opportunity blong disaster mo causem other social problem. Hemu gud se infomasen hemi mas kassem everi pipol blong mo wanwan person hemi save gud evacuation process mo ol nara safety program blong supportem komuniti. Nogat woman hemi mas rely lo infomasen we husband nomo ikiv aot.
- Usem komuniti network mo mekem sua se Komuniti Disaster Komiti(CDGs) oli mas gat wan communication plan( we hemi includem tekem infomasen igo kassem olgeta pipol wetem special nid). Olgeta ia nao isave receivem emergency support quick taem.

**Step 2 |** Trainem olgeta woman, gel, boe mo pipol wetem disability lo evacuation procedure mo mekem sua oli participate long olgeta aktiviti.

- Ol woman, pikinini mo pipol wetem disability oli pipol we oli gat low status long komuniti. Hemu important se olgeta pipol ia oli mas gat powa mo save mekem decision blong savem laef blong olgeta wanwan mo laef blong nara pipol. Information hemi mas kassem olgeta ia tu.
- Trainem ol woman, gel, boe mo pipol wetem disability long evacuation procedure mo involvem olgeta ol wok blong evacuation.

### Assessments

**Step 1 |** Mekem sua ol pipol wetem special nid(women mo pipol wetem disability) oli mas part lo assessment team.

- Includem equal namba lo ol woman mo man long assessment team. Mekem sua se ol nid blo ol woman mo man hemi record mo formem part lo assessment finding. Ol woman bae oli feel safe mo free blong storian more taem igat woman long team blong assessment. Oli save providem mo infomasen taem oli toktok long nara woman.
- Includem pipol wetem disability long assessment team. Mekem sua infomasen long pipol we oli nidem mo support, i mas gat record long assessment findings.

**Step 2 |** Conductem separate miting wetem pipol wetem special nid.

- I gat long komuniti ol woman we oli no feel free blong sharem infomasen wetem man long assessment, long infomasen we iskret mo sensitive? Promotem equal participation long woman mo man through long separate miting blong ol man mo ol woman. Establishem team blong conductem ol separate meeting ia.
- Conductem separate miting blong ol gel mo boe. Faenem aot ol nid blong olgeta separately. Wanem nao findings yu faenem.

**Step 3 |** Mekem sua ol female assessment team oli wok long wan safe ples, especially lo rural mo remote ples.

- Hemi important se wan woman long assessment team hemi mas safe, taem hemi travel long smol grup. Sappose igat nid blong sam man blong travel tugeta wetem olgeta woman, hemia hemi mas wan priority. Safety blong woman hemi important be no mas usem olsem excuse blong no completem wan assessment.

## Coordination

---

**Step 1 |** Oltaem involvem pipol wetem special nid long level blong decision making mo response.

- Long taem blong wan disaster, woman hemi always gat increased responsibility long haos/komuniti mo hemi no gat taem blong tekem active part long distribution mo coordination long olgeta activities. Makem special effort blong includem ol woman long decision making. Oli save arrangem taem blong miting, lukaotem ol pikinini o nara program we l stret lo woman.

**Step 2 |** Involvem pipol wetem special nid long decision blong distribute supplies.

- Informem ol woman, gel, boe, mo pipol wetem disability long decision retated lo taem, place mo way blong distribution long supplies long komuniti. Everiwan hemi mas kat equal access.
- Mekem sua se pipol wetem special nid oli aware long distribution plan(mekem sua ol woman, hed blong haoshold, pikinini we oli stap olgeta nomo mo olgeta wetem disability oli mas save abaot ol plan mo program.
- Monitor mo mekem record long olgeta we oli receivem ol supplies lo saet blong sex, age mo disability mo taem faenemaot olgeta issues blong unfairness, tok stret followem distribution plan.
- Mekem sua se ol distribution supplies ia hemi mitem nid blong ol woman, gel, man mo boe.

## Information

**Step 1 |** Mekem sua infomasen long response activity hemi mas go aot long everi network blong olgeta woman mo nara network, olsem komuniti lida.

- Mekem ol memba blong komuniti oli aware lo response activity programs mo mekem sua oli recordem everi supplies. Sappose information hemi go aot long ol jifs mo komuniti lida nomo, igat high risk se olgeta wetem disability, ol woman, ol gel oli no save kassem olgeta supplies ia from might infomasen ino kassem olgeta.
- Insaet lo CDC communication plan, hemi tok abaot information long hao distribution ishud be distributed lo ol komuniti. Motu hemi tok abaot hao olgeta distribution ia hemi mas kassem ol woman mo gel.
- Insaet lo CDC communication plan, hemi tok abaot hao infomasen hemi mas be distributed lo consultant mo gender based violence specialist mo olgeta way blong handlem ol cases blong exploitation mo abuse, long wan safe mo confidential fasion. Hemi includem tu contact blong ol referral service blong kassem support.
- Setemap wan system blong hemi mas accessible, confidential mo everiwan I save gat access lo hem. Hemia blong riportem suggestion mo complaint.
