

Gender mo Protection Checklist | WASH

From wanem nao gender mo social inclusion mo proteksen hemi important blong save long saet blong WASH Program?

- Long taem blong disaster, wota, sanitation mo hygiene(WASH) oli important blong stopem sikness . WASH program hemi save providem help, prevention mo protection lo olgeta affected pipol. (i.e prevention lo olgeta fasen nogud olsem exploitation, abuse, violence mo raurau).
- Mekem sua se lo prevention program hem i no causem olgeta nara problem. Olgeta toilet ino gat laet mo lok lo doa mekem se inogat proteksen lo ol woman mo gel olsem sexual abuse.
- Everiwan I gat raet lo wota, sanitation mo hygiene facility. So hemi important tumas se olgeta facility ia hemi mas gat long ples mo olgeta wetem special nid tu I save gat access long hem.
- Save lo komuniti nid fastem bifo developem WASH program. Understanding ia hemi save helpem mo speedim up program blong recovery mo resilience.

Assessment

- Toktok stret wetem pipol wetem special nid mo meksua oli vois mo concern blong olgeta I addressed blong komuniti. Encouragem olgeta woman, gel, boy mo olgeta wetem disability blong oli save toktok olgeta nomo.
- Checkem namba blong ol ples blong tekem wota, ol toilet, haos blong swim againstem namba blong ol woman, gel, boe mo ol man we oli stap usem.
- Check se hao mas nao inidem improvement mo hu nao bae I usem.
- Check location blong WASH Faciliti mo namba wei inided. Wota collection blong komuniti inaf? E.g Hao mas container nao komuniti ia inidem?
- Assessem nid lo saet blo wota, sanitation mo hygiene. Assessmen ia hemi mas considerem olgeta wetem disability tu mo recordem finding by sex, age disability mo prioritisem olgeta.
 - Hao nao olgeta woman, gel, man mo boe iusem wota?
 - Wanem nao nids blong olgeta woman mo gel taem oli sikmoon, oli kat bell or mama we istap kivem titi long pikinini.
 - Igat any facility long komuniti blong helpem olgeta wetem disability mo long olgeta pipol wetem special nid motu olfala? Suppose yes then hao mas? Suppose no then hao mas mo wanem kind support nao WASH isave help lo hem?
 - Igat any possible risk lo saet blong olgeta facility blong WASH? E.g harrasement, sexual abuse long ol woman, ol gel, mo boe from or long source blong wota, toilet mo ples blong swim. Source blong wota hemi safe lo olgeta pipol wetem special nid olsem olgeta we oli kat kil, olfala mo disability?

Access

- Prioritisem olgeta nids wetem ol WASH Facilities. E.g hao mas igo blong supportem nid blong ol woman, pikinini mo olgeta pipol wetem disability. Everiwan igat access lo wota?
- Locatem wan gud point blong putem water long hem. Wota point ia hemi mas accessible long olgeta wetem special nid tu. Wota point hemi mas klosap lo ples we public transport isave pass long hem mo oli save transportem wota igo lo home. E.g pipol I save walkabaot 500m nomo. Cordinatem wok wetem local authority, education, health sector mo mekem sua se public space mo skul mo health post oli gat access lo service blong WASH.

- Mekem sua se 15% long WASH facilities I mas rijem olgeta pipol. Providem olgeta samting olgeta hand rail, ramp, safety barrier mo ples blong sit daon mo wait from WASH service. Choosem ples we igat shade mo prioritism se olgeta woman mo pikinini ikassem service fastem. Encouragem friendly environment.
- Faenemaot ol nid blong pipol we oli liv wetem special nid blong support blong WASH isave supportem olgeta. E.g design hygiene promotion activiti blong olgeta woman, man, gel mo boe.
- Meksua se igat gender balance long team blong ol staff. Identify ol woman staff olsem ol contact point blong ol woman mo gel long komuniti.
- Communication mo Information: Usem ol different way olsem(e.g extension woker, radio, sms messaging, poster, niusleta, television or loudspeaker) meksua se information hemi kassem everiwan(Olsem olgeta we oli no save rid mo raet).
- Followem principles blong “Buidem Bak Better” long taem blong constructem WASH facilities blong improvem access long service from olgeta wetem disability mo olfala.
- Toktok wetem Komuniti lida mo discussem ol possible way we isave affectem program mo facilities blong WASH. Discussem ol way blong improvem ol issues ia mo improvem WASH program. Olsem blong stoppem discrimination, exploitation mo abuse.

Safety mo dignity

- Lo taem blong designem, ples blong putem ol toilet, ples blong wash mo swim hemi mas ol taem promotem safety blong olgeta users.
- Discussem ol way blong safety wetem pipol long special nid. E.g
 - Access lo rod long wota point, toilet, ples blong wash mo swim hemi safe?
 - I gat laet lo rod igo lo wan toilet? I gat laet lo toilet haos or no? Suppose no usem ol torch light.
 - I gat separate toilet mo bathing facilities blong olgeta man mo woman? Putum label long doa suppose ino gat.
 - I gat lock lo doa blong toilet mo bathing facilities blong privacy?
 - Mekem sua se olgeta pikinini we I participate lo collection wota, wok i ino stoppem olgeta blong go long skul. Distance I klosap or long we? Ol container blong kassem wota I stret lo age blong pikinini?
 - Igat safety patrol blong stap checkem long olgeta facility blong WASH?
- Long promotion long hygiene includem gender based violence prevention message. Mekem sua se lo everi WASH Komuniti Outreach same message ia hemi mas stap long hem. (Includem information lo hao blong reportem wan risk mo hao blong accessem care).
- Monitorem mo kipem ripot long olgeta risk or problem lo WASH facilities. I gat risk lo exploitation, abuse, violence mo injury lo pipol wetem special nid? Check gud olgeta samting ia.
- Ripot bak long gender based violence specialist. Providem ol suggestion long ol way we I safe mo confidential long fasion blong handlem ol case olsem exploitation mo abuse. Included nem mo contact blong ol support service we olgeta pipol oli kassem care support long olgeta.

Participation, empowerment mo accountability

- Providem training mo guideline long olgeta staff lo situation mo capacity blong olgeta pipol wetem special nid.
- Everiwan I gat raet long wota we I klin blong drink mo usem. Oli gat raet lo ples blong kassem wota mo ples ia hem i klin mo hygienic. Includem information olsem long session blong awareness.
- Ol taem includem olgeta pipol wetem special nid blong oli mas tekem part long discussion mo decision making about WASH facilities. E.g mekem sua se olgeta woman, boe mo gel mo pipol wetem disability oli participate lo decision blong layout mo design blong WASH facilities, supportem olgeta woman mo mekem sua ol woman tu oli mas serve lo WASH committee.
- Mekem sua se olgeta woman mo man tugeta I part lo construction, operation mo maintenance long everi type blong wota mo sanitation facilities, includem well, pump, water storage, treatment, water quality,

monitoring, distribution system, toilet mo bathing facilities. Participation long wok bae hem i providem ol training blong olgeta woman mo man we ol i wok.

- Providem training mo policy lo olgeta staff. Long saet prevention blong sexual exploitation mo abuse. Providem clear information long komuniti no explainem se olgeta woman mo gel oli no gat nid blong payem or providem service blong ol i save kasem wota mo access long WASH services.
- Setemap wan system we hem i accessible, safe mo confidential. Pipol oli mas save service mo support blong system ia mo oli save kam givem tinkting mo complaint blong olgeta.

Monitoring

- Collectem data lo olgeta pipol we oli kassem WASH services. Collectem data long sex, age mo disability.
- Monitorem program mo faenem aot olgeta we oli no accessem WASH facilities mo providem support long olgeta we oli facem concern.
- Monitorem mo recordem ol nara issues we hemi caused from WASH program. Ol niu issues. E.g Olgeta facilities blong WASH ino bin kiln mo icausem risk lo health blong ol pikinini. Checkem suppose I gat any risk diseases long olgeta pikinini.
